

(NOHVA), TBQ Sport Club, Inc., the USDA Forest Service Nebraska National Forest, Nebraska Public Power District, Loup Power District, d the Nance County Sheriff's Department, the City of Alliance, and the Alliance Motocross Association. I / We agree to thoroughly inspect any of the USDA Forest Service land, Loup Power District land, Nebraska Public Power District land, City of Alliance land, or places or areas that I / we enter to insure that they are safe and reasonably suited for my / our use.

If, after a thorough inspection of places or areas NOHVA is involved with, and if any of them are found to be unsafe or not suited for my / our use, I / we will vacate the unsafe or unsuitable land, places or areas and immediately advise NOHVA and / or and the area land owners, managers or chapter officials of these un-safe or unsuitable conditions.
